As a table renter at the Midland Gun Show, you are required to sign this "Hold Harmless Agreement" agreeing to relieve Midland County Sportsman's Club (MCSC) and its members from liability for accident, theft, acts of violence, injury to yourself, your guests, and property, and you accept responsibility for any liability arising from acts or lack thereof by yourself, your helpers, associates or guests and you agree to hold harmless and indemnify MCSC and its officers and members for any such acts or lack thereof.

The payment of table rental does not purchase any insurance on your behalf nor does it entitle you to insurance coverage for any hazard caused by you, nor does it insure you, your business, your employees, guests, agents or anyone associated with you in any way, for any injury, damage or loss resulting from the acts of others at the gun show. Neither the show operator (MCSC) nor the facility owner (Midland County Fairgrounds) provides you with insurance coverage or liability protection of any kind. In your relation to the Midland County Sportsman's Club and Midland County Fairgrounds, you are solely responsible for any acts or consequences associated with your participation in the 2012 Midland Gun Show.
